On Monday, June 29th. The annual



Almas Travels to San Antonio for 135th. Imperial Session

On July 4, 2009, several members of the Almas Shriners Divan and their families traveled to San Antonio, Texas to take part in the 135th Imperial Session of the Shriner's International. Other members of the delegation traveled separately and arrived by air and by car. This was an important session as there was a record 37 pieces of legislation to be voted on, including proposals to close 6 of the 22 Shriner's Hospitals for Children (SHC), re-cast the 6 hospitals for ambulatory care, and to begin accepting third party payment in the form of insurance.

The plane from Baltimore Washington International Airport was filled with Shriners from several different Shrine centers. Representatives to the Session were actively reviewing and discussing the options even as the plane was heading to San Antonio. After arriving at the hotel and getting checked in, it was necessary to travel to the headquarters hotel to register for the Session. At the headquarters hotel, the importance of the decisions to be made at the Session were brought more sharply into focus by the presence of present and former patients of the Galveston SHC, their families, and members of the Galveston Board of Governors handing out flyers and campaigning to re-open Galveston SHC. It should be noted that operations at Galveston SHC had been suspended as a result of damage caused by Hurricane Ike and Galveston was one of the 6 slated for permanent closure.

After spending the weekend getting oriented and registered, the four days of meetings started Monday morning. Imperial Sir Doug Maxwell had planned the week such that the most controversial of the legislation was handled early. The resolution to close the 6 hospitals was amended to delete the names of the 6 hospitals and then the entire resolution was withdrawn. A resolution to re-open Galveston SHC was adopted. The SHC Board of Trustees was given the authority to begin the transition of the 6 hospitals toward ambulatory care and to take other cost saving measures. Imperial Sir Doug Maxwell was elected to replace Imperial Sir Ralph Semb as president of the Board of Trustees for SHC.

Another piece of potentially contentious legislation was third party pay. This legislation was adopted. The passage of this piece of legislation means that within the next one to two years, all SHC will be accepting health insurance from those patient's families who have insurance. For those families who do not, or for those who exceed the maximum limits of their policies, SHC will continue to cover the cost of the care such that there will be no out of pocket costs to any patient or their families in keeping with the original concept upon which Shriner's Hospitals for Children was founded. In addition, the type of care offered will not be affected by the insurance companies' willingness to pay.

The best way to get from one place to another in San Antonio is the Riverwalk. At just over 2 miles long, the Riverwalk sits 15 to 20 feet below street level and is lined with restaurants as it winds its way through downtown San Antonio. There are river taxis' to take people on tours and on at least one occasion, a Shrine dinner was held on board one of the taxis' as it floated by the hotel in which Almas was staying. Getting almost anywhere in San Antonio that a Shriner needed to be was possible by walking the Riverwalk.

Socially, Illustrious Sir Donald Ferguson and his Lady Debbie hosted all Almas nobles and their families at a dinner high atop the Tower of the Americas. The food was excellent and the view was amazing. During the Potentate's Dinner, we were able to greet Noble Hector Massiotti, president of the Almas Uruguay Club and his Lady Miriam and Noble Alberto Canteo, also of the Almas Uruguay Club. Nobles Hector and Alberto had been invited by the Imperial Sir to speak at the Imperial Session after he had visited Uruguay in May of this year.

Lady Iris Gordon and daughters Adrienne and Samantha took time to visit Sea World and had a wonderful time. Most of the attending family members not involved in the Session took a day bus tour of the outlying areas around San Antonio. While on the bus, they visited Fredericksburg, Texas, and stopped in the small town of Luchenbach, Texas (population 3).

There was also a stop at a museum dedicated to Admiral Nimitz. The Imperial Sir's evening was a concert by Franky Valli and the Four Seasons. The entertainment was wonderfully received with Nobles and their ladies dancing in the aisles. Imperial Sir Doug Maxwell introduced the entertainers by saying that "they were playing on the radio in the front seat while you were playing in the back seat".

The parade proved to be as entertaining as always with wild cars that bounced around, mini motors and motorcycles from all around the country and clowns, clowns, and more clowns. A poignant moment occurred at the beginning of the parade. Deputy Imperial Potentate Terry McGuire had passed away suddenly earlier this year. The parade was led by Imperial Sir Douglas E. Maxwell walking along side his car. He was followed by a noble of Alzafar Shriners, Imperial Sir Terry McGuire's home Shrine Center, leading a saddled rider less horse, representing the fallen leader. Each member of the Imperial Divan followed, most on foot, including Imperial Sir Jeff Sowder who had been elected to the position of Imperial Outer Guard earlier that day.

The last morning of the Session started early with much legislation still to be addressed. After completion of the voting, Almas Nobles from Uruguay were introduced to speak. Noble Alberto Caneto spoke eloquently about Uruguay, the Masonic Family there as well as the need for the type of care that only Shriner's Hospitals for Children can provide. This was followed by Imperial Sir Jack H. Jones installation as Imperial Potentate and the closing of the Session.

That evening, several of the Almas delegation had a seafood dinner at Joe's Crab Shack. Afterwards, everyone retired to the Almas hospitality room before getting ready for the early flight home the next morning.

The Almas delegation would like to thank the Alzafar Shriners for hosting a wonderful week.

2009 White House Christmas Ornament Sale

The only president of the United States elected to two non-consecutive terms, Grover Cleveland served as the 22nd president from 1885 to 889 and as the 24th from 1893 to 1897. The 2009 White House ornament commemorates the 24th presidency and it is the second of two produced in Cleveland's honor by the White House Historical Association.

This second ornament illustrates the special place of the Christmas tree in the holiday celebrations of President Cleveland's young family. The central hologram depicts the south façade of the White House after an evening snowfall. The warm glow of the first Christmas tree to be lluminated by electric lights is seen through the tall windows of the second floor Oval Room beyond the center of the columned portico. This softly colored view is based on a modern watercolor rendition by Margaret Huddy, a Washington, D.C.-based painter.

The reverse side of the ornament recreates a scene from the tree-trimming parties of President and Mrs. Cleveland, which were held annually for their children and those of cabinet members. The words of a period newspaper report help to describe the president's delight in preparing Christmas day for his young family. A finely crafted gold plated wreath of snowflakes, painted ice blue and white, frames the oval ornament.

First Lady Charlene's Program Supports Emergency Transportation for Burn Patients

First Lady Charlene McGuire's fundraising program "Giving the Gift of Hope, Life and Dreams," will benefit children who need emergency transportation to one of the Shriners Hospitals for Children specializing in expert burn care.

Proceeds from her yearlong initiative will be donated to Shriners Hospitals for Children's emergency patient transportation fund, which helps sponsoring Shriners International temples cover transportation costs for burn patients when needed.

Since the early 1960s, when Shriners Hospitals for Children first began offering pediatric burn treatment, thousands of patients have been given a second chance to lead productive lives, thanks to the expert medical care they received at these state-of-the-art hospitals.

When children experience burn injuries, receiving the kind of multidisciplinary pediatric burn care available at Shriners Hospitals for Children is paramount to their overall recovery. Since their injuries can be severe and even life-threatening, burn patients often require transportation to Shriners Hospitals for Children in medically equipped airplanes with medical professionals on board to monitor them.

In 2008 alone, the Shriners Hospitals for Children emergency patient transportation fund provided \$670,000 for medical air flights for 45 burn patients. And, the cost for these medical air flights is rising every year. Since 2005, the average cost for each of these flights has increased by approximately \$5,000.

"It's clear that the costs for these flights are escalating," said First Lady Charlene McGuire. "Often, temples have to make arrangements to transport a burned child to one of our hospitals immediately, so the funding has to be there. Many temples may not have funds to cover these emergency transportation costs. Proceeds from my program will help meet this important need."

As First Lady Charlene makes her visits throughout the Imperial Year, she asks that in lieu of personal gifts, nobles and ladies make a donation to "Giving the Gift of Hope, Life and Dreams." With each donation of \$25, they will receive their choice of a beautiful silver and gold lady's pin, or a handsome gentleman's tie featuring the "Editorial Without Words" image.

Uruguay Trip

wheelchairs on site. The work they are doing is truly making a difference in all of the children and their families that they help.

That evening, we met with MWB Jorge Walter Caillabet, Venerable Gran Maestro, and Gran Lodia de la Masoneria del Uruguay, some of his Grand Lodge Officers plus the Officers of our Shrine Club at the Grand Lodge building. We discussed the future and the importance of the Club. The meeting was followed by a wonderful time of fun and fellowship over a delicious dinner.

The next morning we returned to the Grand Lodge to meet with the Officers of the Club. Hector Massiotti,



President of the Club, and his Officers discussed the concerns of the Club. We also talked about the Ceremonial that would be held the following morning. Imperial Sir Doug Maxwell thanked Hector and the Club for all the work that they are doing in Uruguay. He also told Hector that if possible, he

The lunch was served in a room at the top of the hotel, some 30 stories up, with a truly breathtaking view of the city.

That evening we had a Club meeting which was followed by a dinner.

Proposed Change to the By-Laws

The Membership Committee and various Nobles propose the following By-Laws change.

We feel that current members of the Armed Forces should be given a 15% discount in their initiation fee. This discount would be applied to the initiation fee only (current initiation fee is \$100.00; the discount would be \$15.00). The annual dues, Hospital assessment, and Per Capita fee would not be affected. This discount would still be within the limits allowed of the minimum required initiation fee required by the Imperial By-Laws. We believe that this discount would encourage the members of the Armed Forces to join the Shrine.

The By-Laws now reads:

Section 5.1 Initiation Fee. The initiation fee shall be determined at a stated or special meeting of the temple after notice has been given to each member stating the proposed amount of the initiation fee. The initiation fee shall not be less than prescribed by the bylaws of the Imperial Council. It must be paid in full prior to initiation. If a candi-

date is rejected or accepted and does not present himself for initiation, he is entitled to the return of his fee upon request.

The proposed change to the By-Laws would be to <u>ADD</u> the following sentence:

Active members of the Armed Forces will receive a discount of 15% of the current initiation fee.

If approved the By-Laws would then read:

Section 5.1 Initiation Fee. The initiation fee shall be determined at a stated or special meeting of the temple after notice has been given to each member stating the proposed amount of the initiation fee. The initiation fee shall not be less than prescribed by the bylaws of the Imperial Council. It must be paid in full prior to initiation. If a candidate is rejected or accepted and does not present himself for initiation, he is entitled to the return of his fee upon request. Active members of the Armed Forces will receive a discount of 15% of the current initiation fee.

This proposed change will be voted on at the Business Meeting on September 29, 2009.


Special thoughts and prayers go out to all of our Club members who have been sick this summer and we wish them a speedy recovery.






