2010 White House Christmas Ornament Sale



The 2010 White House Christmas ornament honors the twenty-fifth president of the United States, William McKinley, and celebrates the role of music in the traditions of the White House. The McKinley administration (1897–1901) is remembered as a time when the nation moved beyond its continental boundaries to become an international power. The American people idolized McKinley during his presidency, so suddenly cut short by an assassin's bullets six months into his second term.

In celebration of the nation's patriotic mood as the century turned, the illustrations commissioned for the 2010 ornament feature festive, colorful scenes from the annual Army Navy Reception at the White House in 1900. The front face of the ornament depicts members of the United States Marine Band performing on the snow covered North Drive as arriving guests disembark from their carriages. The reverse side of the ornament shows the band playing patriotic airs for President and Mrs. McKinley and their party in the flag bedecked splendor of the East Room. It was in this High Victorian East Room that the McKinleys began the era of "musicales" (receptions with music as the leading feature) at the White House, a tradition that continues to this day.

Contrary to the old practice of scheduling considering the convenience to the family or Nobility, every effort will be made to limit stays to the minimum medically essential. To do otherwise might appear to place Shriners Hospitals in the position of appearing to favor patients from a particular state or states. No more in one day and surgery the next unless medically required.

It appears that some of the Nobility have been offended by the attention paid to their age and are no longer involved with patient transportation. 

Almas Uruguay Shrine Club

After evaluating other potential groups for assistance, the Nobles in Uruguay elected to assist the "Franklin Delano Roosevelt" School located in Montevideo (a non prophet private institution devoted to assisting 81 handicapped children ages 6 to 18 years old).

Attending to that School and being a beneficiary of their assistance is free for those students with either physical or cerebral diseases and most of the attendees come from families who struggle to make it to the end of the month with their meager salaries.

During the day the children are taken care of by professional teachers who specialize in a very innovative way of teaching, recreation and recovery for each student. Also, and as a part of their daily routines, they receive three very healthy meals.

Another benefit for the students is that a School Van comes to their home to pick them up in time for them to get to the school by 9:00 am and drops them off after 5:00 pm when the daily classes finish

However even with the assistance they are receiving at present, they have extremely urgent economic needs.

Proposed by the Board and approved by the Uruguayan Shrine Nobility, Almas Uruguayan Shrine Club, committees have responded to provide immediate assistance such as:

1. Making the necessary contacts with the proper Government of-14 - almas alibi ficials to expedite the decision making process regarding subsidies.

- 2. Contacting key actors in the Uruguayan society at different levels, in order to acquire both monetary and useful donations.
- 3. Encourage non-members of the Nobility, to donate a 32" LCD TV set, a DVD player, some DVDs with films for the children. Other non-members also made all the arrangements and paid for the children to experience live shows with clowns, magicians, pets and puppets.
- 4. Arranging meetings between the Uruguayan Nobility "Medical Advisory Committee" and a team of specialized Medical Doctors of the School to review and categorized the most urgent cases of the children who may qualify for application for treatment in the Shrine Hospitals.
- 5. Last but not least, even nowadays, we are in the process of working with the "Franklin Delano Roosevelt" School authorities to identify new ways of assistance.

As you can see no economic assistance has been given by the Club (since we do not have enough money to do it), nevertheless, we managed to find other ways to help them and make a difference in their day to day life. The Nobility of Uruguay believe that as Nobles we can do a lot to support these children in need, when medical assistance is not the only kind of assistance they are lacking.
