Almas Yacht Club Fishing Trip

Almas Yacht Club is hosting a fishing trip on August 9th out of Deale. The outing will entail the following, plus lunch upon returning to dock:

- Up to six hours on the water
- Trolling, chumming, bottom fishing
- Includes all fishing licenses and insurance
- Includes all rods, reels, bait, and tackle
- Includes ice for you catch
- \$75 per person

You may bring: food (sandwiches in your own cooler), beverages of your choice (*remember water, dehydration is real also we are not encouraging alcoholic beverages*), non-slip shoes, rain jacket (better safe than sorry), sweater or light jacket as it gets chilly out on the water, sunglasses, sun screen, camera, lucky fishing hat, and a cooler to transport your catch home.

Driving directions from DC -Take Rt. 495 to Rt. 4. Take Rt. 4 south 15 miles, take right onto Rt. 258 (Bristol/Deale). Follow Rt. 258 5 miles to first stoplight. At the stoplight make a right onto Rt. 2. Proceed 1/4 mile and take first left onto Rt.256. Follow Rt. 256, 2 1/4 miles to Dockside Restaurant & Sports Bar. Turn right to rear of restaurant to unload (under arch next to restaurant); then park in lot in front of restaurant.

Important: You must be at the dock by 6:00 AM.
